In CONSIDERATION of being granted the benefits of membership in the American Modified Series THE UNDERSIGNED, for myself, my personal representatives, heirs, next of kin, successors and assigns DO:

- A. HEREBY AGREE TO ASSUME ALL RESPONSIBILITY FOR ALL ACTS OR ACTIVITIES of me as a result, of my participating in an American Modified Series event or time trial during the actual sanctioned period.
- B. HEREBY AGREE to be bound by all the rules of the American Modified Series and agree that decisions of its officials and/or interpretation of its rules will be governed exclusively by the administrative review and appeal procedure set forth in such rules.
- C.
